To develop and maintain classifications that accommodate the complete domain of family/general practice

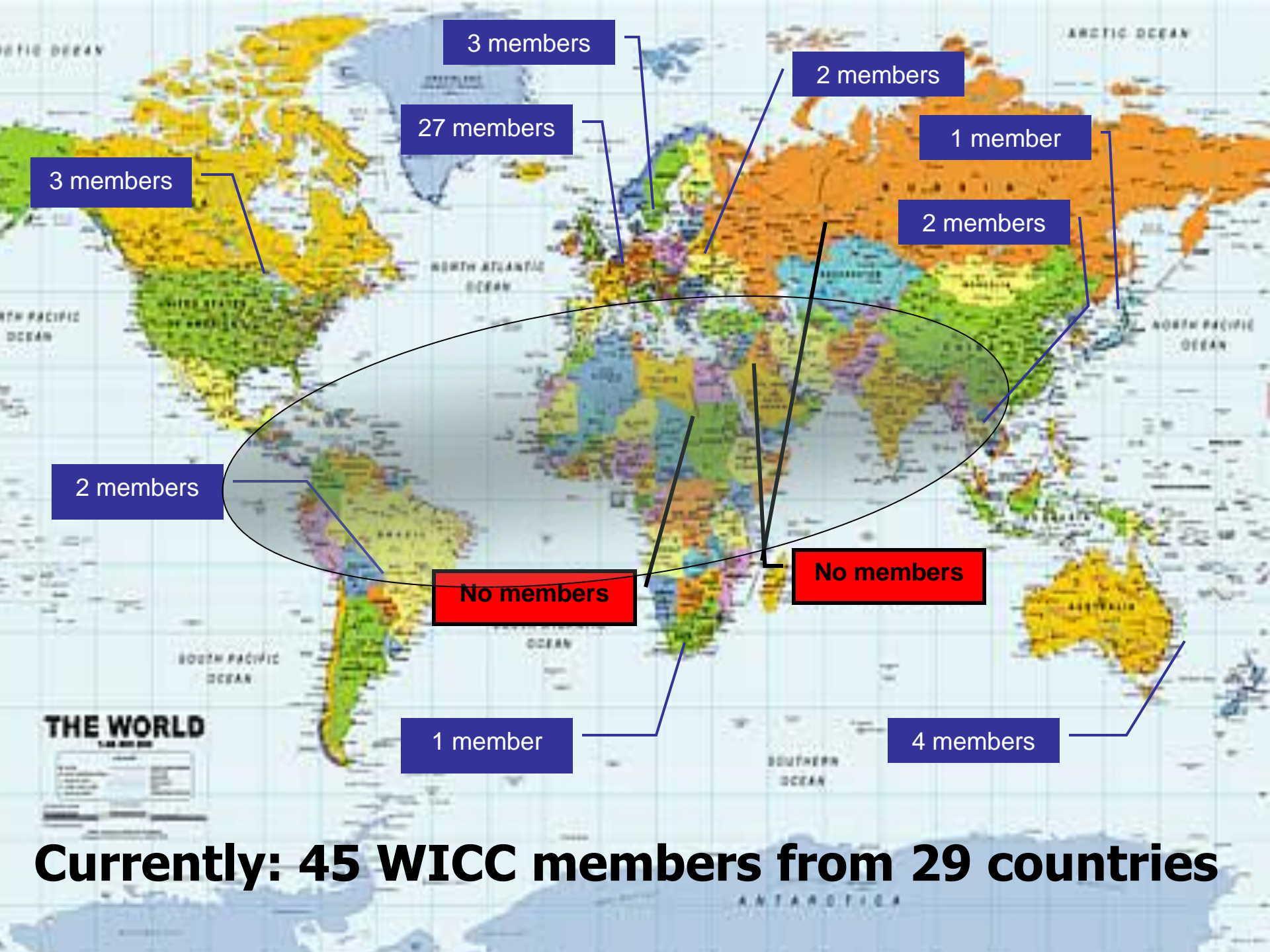
AND

3. Support for a "Consortium" to develop ICPC-3 and integrate it into health IT systems around the world

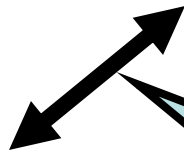
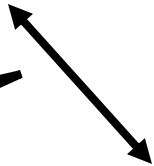

Current: Wonca WP

- Volunteer work to maintain ICPC-2
- Project-specific approval for work toward ICPC-3
- Harmonization and collaboration as time and resources allow
- No organized marketing
- Continued one-time “sales” model for licensing
- **Missed opportunity**

Goal: **Consortium**

- Member countries support costs of development of classification tools
- Support also covers maintenance, dissemination, training, harmonization
- Classification tools are free, open-source, with use/support agreements in place
- Member countries have role in governance of work done (management board)

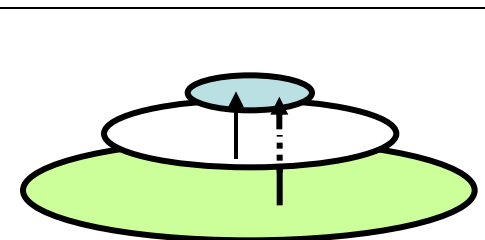
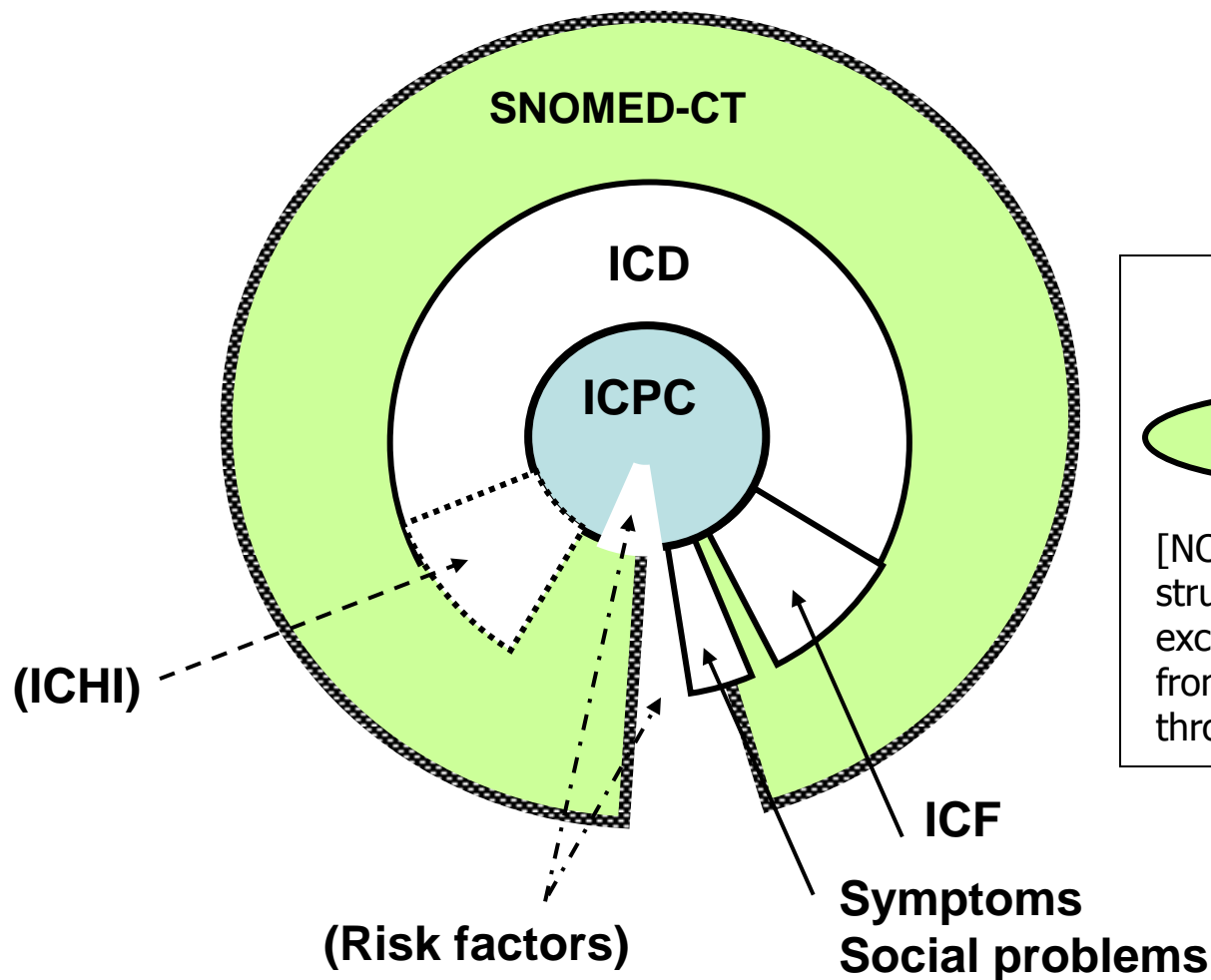
Progress toward Consortium

M/Y	Action
9/2009	Wonca, WICC agree to explore creation of Consortium to maintain and develop primary care classification tools
12/2009	Initial business plan, budget submitted by WICC
7-8/2010	Wonca letter to Colleges – initial solicitation of interest in funding Consortium
10/2010	Initial Wonca proposal for funding of Consortium
1-6/2011	Some interest expressed, mostly from Europe
Spring 2011	Initial discussions with ACG International
6-8/2011	Discussions with Cielo MedSolutions (US) on support
4-9/2011	Series of teleconferences with Wonca core executive – support for proceeding with “phase 1” of Consortium
1/2012	Wonca Executive denies request for planning funds
1-7/2012	Unproductive discussions with CEO candidate, Wonca Core Exec on funding of classification work; Cielo withdraws, drops license
